## Your request:

- UK not doing enough to keep up with climate change? You say renewables will reduce energy prices for UK consumers, please tell me how when every home in the UK is paying £500 a year in subsidy for renewables?
- 2. As an overriding question please provide me with all of the information CCC holds which specifically identifies how many wind turbines solar panels and grid scale batteries the UK would need to transition to renewables bearing in mind Lord Deben has already said that an all electric UK would have a maximum demand of 150Gw's. To achieve an all electric UK what data does the CCC hold which identifies how long it would take for every road and path in the UK to be dug up to double or triple the size of cabling needed to handle the huge increase in load? On the estate where I live there are 3 bed semi's and terraces which garages incapable of taking a mini yet a large number of houses have a work van and two cars. How would these people charge all three vehicles overnight when most are parked on the pavement?

Please provide me with the specific data that you hold which identifies in full knowledge that if Co2 is the primary cause of a change in climate, how when the UK emits 0.000012% of man made Co2 could the UK ever reduce its emissions to the point at which it could influence the way in which its individual climate and the global climate?
- 4. Please provide me with specific data that concludes that if everyone in the UK died next Tuesday such action could overwhelm the reopening of 200 coal mines in India, 42 new coal mines and hundreds of new coal fired power stations being built in India and China?
- 5. Please provide me with the specific data that you hold which shows beyond reasonable doubt how owning an EV instead of a petrol or diesel car can save the planet when Volvo have admitted that an EV emits more Co2 during its life than a petrol or diesel equivalent?
- 6. Please provide me with the specific data you hold which shows beyond reasonable doubt that digging out 500,000 pounds of stuff out of the environment which is supposedly at risk from Co2 to make one Tesla EV battery can save the planet? Because once every last pound of our finite

- 7. Please provide me with the specific data you hold which shows beyond reasonable doubt if fresh water is limited how does wasting 500,000 gallons of fresh water to assist the mining and refining of 500,000 pounds of stuff mostly rare finite resources needed to construct one Tesla EV battery?
- 8. Please provide me with the specific data you hold which shows how by abolishing fossil fuels will we be able to ship the billions and trillions of tons of rare finite resources and refining those resources to make 1.4 billion EV batteries?
- 9. Please provide me with all of the specific data you hold which shows how the world can provide Tampons and sanitary pads for women when fossil fuels are abolished knowing that these products are made from petrochemical products and how will you explain this situation to women?
- 10. Please provide me with all of the specific observed data you hold which shows how the climate is changing when observed historical weather data for instance shows no evidence that either in incidence or extreme weather is worse now than within recorded historical data? (China flood 1887 2 million died, Germany Christmas flood 1717 14,000 died, American dust bowl era 12,000 died in two weeks)
- 11. Please provide me with all of the specific observed data you hold which shows in detail how the CCC determines that the UK is not keeping up with climate change and what exactly how the CCC determines what is climate change?
- 12. Please provide me with all of the specific observed data you hold which shows in forensic detail how the CCC determines why we should see a change in climate is worse when the evidence shows beyond reasonable doubt that in the 1300's the planet struggled to feed 350 million whereas now because of fossil fuels, nitrogen fertiliser from methane, longer growing periods because of subtle warming since the depths of the LIA of between 0.85C and 1.1C and a miniscule increase in atmospheric Co2 the planet now produces enough food for 10 billion, why is this bad? Sea level rise maybe 6 inches by 2100. And with thousands of ARGO buoys deployed in the oceans we can measure ocean temperature down to 2000 metres which register a trend of 0.02C/decade or 0.16C by 2100. Sea level rise has not accelerated for 90 years and remains at 1.7mm/year or 5.35 inches by 2100. No observed evidence of crisis and no evidence that Met Office perverse scientifically illiterate speculation is any more valid now than 50 years ago.

## Our response:

Thank you for your request. This has been treated as business as usual correspondence. This is because the FOI Act relates to recorded information held by a public authority on the day a request is made. The reports, research and analysis on our website provide our assessment and views to some of the questions you have asked. We have pulled out some of the relevant sections from recent reports in answer to your questions below. However, your remaining questions draw upon a wide range of publicly available information and seek our opinions on a number of issues and so do not fall within the scope of a request under the FOI Act.

- 1. There are a number of sections in the CCC's 2022 Progress Report to Parliament which outline how the transition to Net Zero is affordable and can help limit energy bill costs to consumers. In particular, we'd suggest reading box 4.3 Securing a long-term climate advantage in response to the consumer energy price crisis, page 200, and section 3. - 2. Our Sixth Carbon Budget advice to Government sets out a number of scenarios which list the actions required across the economy in order to reduce UK emissions to Net Zero by 2050 at the latest. In our balanced pathway, the low-carbon share of energy supplies increases from 50% currently to 100% by 2035, while demand increases by 50%. To meet that demand, the electricity generation sector summary outlines the contribution from renewables and firm power.
