Dear Committee on Climate Change,

In Chapter 4 ('Wider Economic and Social Considerations') of your communication concerning setting the Fifth Carbon Budget you stated:

'We have considered the main fiscal impacts likely to arise as a result of our fifth carbon budget scenarios, both positive (e.g. EU ETS auction receipts) and negative (e.g. lower fuel duty receipts as vehicle fuel efficiency improves). Our conclusion is that the overall net impacts are likely to be manageable, given the time available from now to the fifth carbon budget period to make adjustments.'

Would you be able to provide me with the full figures detailing the costs of the Fifth Carbon Budget that led you to conclude that the overall net impacts are likely to be manageable?
